Charles Seignious Honour (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released and by these presents do Grant, Bargain, Sell and Release unto the said Charles Seignious Honour, all that lot of land on Pendleton Road, just beyond the incorporate limits of the City of Greenville and near the Brandon Mills, known as No. 6 of Honour Row, measuring on Pendleton Road, Beginning at No. 5 and running West to No 7- sixty (60) feet thence South to Southern Railway right-of-way two hundred (200) feet more or less; thence East to lot No. 5 sixty (60) feet more or less; thence back North two hundred (200) feet, more or less to the Pendleton Road. This property cannot be sold to negroes.

TOGETHER with all and singular the rights, members hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said premises before mentioned unto the said Charles Seignious Honour, his heirs and assigns, forever.

AND I do hereby bind myself, --- heirs, executors and administrators, to warrant and forever defend all and singular the said premises unto the said Charles Seignious Honour, ---

heirs and assigns, against me and my heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
