Wasson corner on East bank of Corbins Creek; thence S. 75-1/2 W. 9.00 chains to stone corner; thence 11-1/2 E. 31.00 chains to beginning corner, containing 32-55/100, Thirty-two and 55/100 acres, this being the same tract of land conveyed to me by Thos. H. McDowell Dec. 19, 1906, bounded by lands of Wm. Stenhouse J.B. and Dr. G.W. Wasson, according to a plat drawn by J. Wister Stewart in 1899.
