POWER OF ATTORNEY

Rnow All Men by These Presents: That the PEERLESS INSURANCE COMPANY, a New Hampshire Corporation, having its principal office in the City of Keene, County of Cheshire, State of New Hampshire, pursuant to the following By-Law, adopted by the Stockholders of the said Company on May 2, 1966, to wit:

"ARTICLE 4 OF SECTION 2 — The President shall be the chief executive officer of the Company and shall have the powers generally possessed by such officer and any additional powers that may be conferred upon him by the Board of Directors or by the Executive Committee. The President or a majority of the Executive Committee may appoint Attorneys-in-Fact, Resident Vice Presidents and Resident Assistant Secretaries and assign to them such duties as may be advantageous to the Company including the execution and attestation of bonds, undertakings, recognizances, contracts of indemnity, and all other writings obligatory in the nature thereof and other documents on behalf of the Company with power to redelegate such authority. In case of the death, absence or inability to act of the President, the duties and powers of the President shall devolve upon an acting President who shall be a Director and shall be designated by the Executive Committee and act until the next Directors' meeting."

This Power of Afforney is signed and sealed by facsimile under and by the authority of the following Resolution alopted by the Board of Directors of the Peerless Insurance Company at its meeting duly called and held on the 14th day of December, 1972.

"RESOLVED, that, the signatures of the President, Secretary. Treasurer, Vice President, Assistant Wee President, and Assistant Secretary may be affixed to any such Power of Attorney or any certified topy thereof or any certification relating thereos by facting and any tent Power of Attorney or any certified topy hereof, or any certification relating thereto bearing such facsimile signatures or facting each standard binding upon the Corporation in the future with respect to any bonds, undertakings, recognizances or contracts of integrality to leach it is but sized."
