Marshall Avenue, Street or house number 112, and adjoining lots (now or formerly) of
Mrs. B.G. Poole, George Morris and others, and known as Lot No. 10 on a plat made by
J.N. Southern, D.S., dated Dec. 14th, 1887 and recorded in the R.M.C. Office for Greenville
County in deed book T.T., at page 649, and having the following metes and bounds:
Beginning at a stake on the north side of Marshall Avenue and running thence N. 15- $\frac{1}{2}$
E. 150 feet along lines of 11 and 12 to a stake; thence N. 66- $\frac{1}{2}$ W. 55 feet along line of
Lot No. 4 to a stake; thence in a southwesterly direction along line of lot No. 9, 148 feet
to a stake on said Marshall Avenue; thence along said Avenue 45 feet to the beginning
corner, containing 22/100 of an acre, more or less, and being the same lot conveyed to me
by W.A. Adams by deed dated December 28th, A.D. 1899 and recorded in said Register's
