TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, John P. McKinney  
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, John P. McKinney, the said John P. McKinney  
in and by my certain note or obligation, bearing date the 24th day of August 1923

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Twenty nine hundred and no/100 (2900.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 24th day of August A. D. 1923, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

I, the said John P. McKinney, shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of September 1923, and on the 20th or before the end of each month thereafter twenty successive months, the sum of Twenty-eight and 34/100 (\$28.34) Dollars, (Twenty-nine Dollars, being the regular monthly installment payable on the 29 Shares of Stock, and Nineteen and 34/100 (19.34) Dollars, being the monthly interest on the advance (or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Twenty-nine Dollars, (Twenty-nine Dollars, being the regular monthly payment on said stock and Twenty-nine and 46/100 (29.46) Dollars, being the monthly interest on balance due); for the next twenty months the sum of Twenty-nine Dollars, (Twenty-nine Dollars, being the regular monthly payment on said stock and Eleven and 60/100 (11.60) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Twenty-nine Dollars, (Twenty-nine Dollars, being the regular monthly payment on said stock and Seven and 74/100 (7.74) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Twenty-nine Dollars, (Twenty-nine Dollars, being the regular monthly payment on said shares of stock and Three and 86/100 (3.86) Dollars, being the monthly interest on balance due.)
