TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Natalie N. Vance of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, the said Natalie N. Vance in and by my certain note or obligation, bearing date the 18th day of October 1923

I am indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of forty-one hundred & no/100 (\$4100.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 18th day of October A. being the regular monthly installment payable on the forty-one (41) Shares of Stock, and Twenty-seven & 33/100 (\$27.33) Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Sixty-two & 87/100 (\$62.87) Dollars, (\$41.00) Dollars, 2584

Dollars, being the the regular monthly payment on said stock and Twenty-one & 87/100 (\$21.87) Dollars, being the monthly interest on balance due); for the next twenty months the sum of Fifty-seven & 42/100 (\$57.42) Dollars, (\$41.00) Dollars,
