

## THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

*Patricia L. Wallace Williams*  
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, the said *Patricia L. Wallace Williams*, in and by *her* certain note or obligation, bearing date the 20th day of November 1923, indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of \$1,100.00 (\$1,000.00) Dollars, with interest thereon at the rate of eight per cent per annum payable monthly, from the 20th day of November A.D. 1923, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that the said *Patricia L. Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said *Patricia L. Wallace Williams* and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against, the said *Patricia L. Wallace Williams* in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereto had will more fully appear.

NOW, KNOW ALL MEN, That the said *Patricia L. Wallace Williams*, in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to *me* the said *Patricia L. Wallace Williams*, in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

Being known as lot #1 block "b" in Sterling Annex, recorded in Plat Book "E" page-141, R.M.C. office for Greenville County, July 1919, and more particularly described as follows:

Starting at a point in the east line of Valentine Street 108.50 feet from the corner of Main Street and the said Valentine Street, the Southwest corner of lot #8, thence thence with the line of the said lot #8-35 W. 155.43 feet to a stake the corner of lots #8 #16 and #15, thence with the line of lot #15 1.32-35 E. 50 feet to a stake, the corner of lots #15 #14 and #17, thence with the line of lot #6, 31.64-35 E. 155.86 feet to a stake in the east line of Valentine street thence with the east line of Valentine Street 50 feet to the beginning corner being the same lot conveyed to *me* by *Patricia L. Wallace Williams* by deed dated November 14th 1923, to be recorded.
