

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

That I, W. M. Hayes

of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, *I, W. M. Hayes*, the said *W. M. Hayes*, in and by *my* certain note or obligation, bearing date the *5th* day of *February* *1924*, indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of *\$100.00 (\$4,000.00)* Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the *5th* day of *February* *A. D. 1924*, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that *I, W. M. Hayes* shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of *February* *1924* and on the 20th or before the end of each month thereafter for twenty successive months, the sum of *Sixty - Six + 67/100* Dollars, *(\$66.67)* being the regular monthly installment payable on the *Fifty (\$50)* Shares of Stock, and *Sixty - Six + 67/100* Dollars, *(\$26.67)* Dollars, being the monthly interest on the advance or loan until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of *Sixty - One + 33/100* Dollars, *(\$61.33)* Dollars, being the monthly interest on balance due; for the next twenty months the sum of *Fifty - Six + 67/100* Dollars, *(\$56.67)* Dollars, being the regular monthly payment on said stock and *Sixty - One + 33/100* Dollars, *(\$26.67)* Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *Fifty + 67/100* Dollars, *(\$50.67)* Dollars, being the monthly payment on said shares of stock and *Eight + 67/100* Dollars, *(\$8.67)* Dollars, being the monthly interest on balance due for the next twenty months pay the sum of *Eight + 33/100* Dollars, *(\$8.33)* Dollars, *(\$40.00)* Dollars, being the monthly payment on said shares of stock and *Eight + 33/100* Dollars, *(\$8.33)* Dollars, being the monthly payment on balance due.) Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said *Forty (40)* shares of stock and the certificate thereof, the amount at such time paid shares by *W. M. Hayes* to be credited as a payment upon the advance or loan made, and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against *W. M. Hayes* in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written reference being thereto had will more fully appear.

NOW, KNOW ALL MEN That *I, W. M. Hayes*, in consideration of the said debt and sum of money as aforesaid, and for the better securing payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars *to me*, the said *W. M. Hayes*, in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

Within the corporate limits of the City of Greenville on the North side of Hamilton Avenue and being known as Lot no. 16 on plat of Survey of Henry P. Mills, recorded in plat book "B" page 223, and having the following metes and bounds, to wit: Beginning at a stake on the North side of Hamilton Avenue at corner of Lot 220, 15 which point is 120 feet East from the intersection of Hamilton Avenue and Culham Street and running thence with line of Lot 220, 15 N. 16-45 E. 175 feet to stake at 15 ft at alley; thence along line of said alley S. 73-45 E. 60 feet to stake corner of lot no. 17; thence along line of lot no. 17, S. 16-45 W. 175 feet to a stake on Hamilton Avenue; thence N. 73-45 W. 60 feet to the beginning corner being the same lot conveyed to me by Sarah M. A. Keltor Durham by deed dated February 5th, 1924, to be recorded.
