

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

That I Elizabeth Johnson of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting

WHEREAS, I, the said Elizabeth Johnson in and by my certain note or obligation, bearing date the 17th day of March 1924 and indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Five Hundred Fifty & 20/100 (\$550.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 17th day of March A. D. 1924, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that I the said Elizabeth Johnson shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville, by and by said, monthly, on the 20th or before the end of the month of March 1924, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Nine & 17/100 (\$9.17) Dollars, Five & 50/100 (\$5.50) Dollars, being the regular monthly installment payable on the Two & 1/2 Shares of Stock, and Three & 7/100 (\$3.67) Dollars, being the monthly interest on the advance or loan until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Eight & 13/100 (\$8.13) Dollars, (5.50) Dollars, being the the regular monthly payment on said stock and Two & 1/2 Shares of Stock, (2.93) Dollars, being the monthly interest on balance due); for the next twenty months the sum of Seven & 10/100 (\$7.10) Dollars, (5.50) Dollars, being the regular monthly payment on said stock and Two & 1/2 Shares of Stock, (2.20) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Six & 9/100 (\$6.97) Dollars, (5.50) Dollars, being the monthly payment on said shares of stock and One & 1/2 Shares of Stock, (2.93) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Six & 22/100 (\$6.22) Dollars, (5.50) Dollars, being the monthly payment on said shares of stock and Seven & 3/100 (\$7.03) Dollars, being the monthly interest on balance due.) Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said 5 1/2 shares of stock and the certificate thereof, the amount at one time paid shares by I to be credited as a payment upon the advance or loan made I, the said Elizabeth Johnson and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against I the said Elizabeth Johnson in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I the said Elizabeth Johnson in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me the said Elizabeth Johnson in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

Beginning on Robinson Street 160 feet from Plum Street thence N. 12 E. 100 feet thence N. 12 E. 159 feet thence N. 71 W. 50 feet thence S. 12 W. 59 feet to the beginning corner on Robinson Street being same lot conveyed to me by A. A. Harwood deed dated December 16th 1893 recorded in Volume 474 Page 94 R. M. C. Office for said Greenville County.
