That I, A. R. Burke, of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Five - 20/100 (\$5.00) Dollars, being the regular monthly installment payable on the Three (3) Shares of Stock, and Two - 20/100 (\$2.00) Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Four - 60/100 (\$4.60) Dollars, being the the regular monthly payment on said stock and One - 60/100 (\$1.60) Dollars, being the monthly interest on balance due); for the next twenty months the sum of Four - 20/100 (\$4.20) Dollars, being the regular monthly payment on said stock and One - 20/100 (\$1.20) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Three - 80/100 (\$3.80) Dollars, being the monthly payment on said shares of stock and Eighty Cents (\$0.80) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Three - 40/100 (\$3.40) Dollars, being the monthly payment on said shares of stock and Forty Cents (\$0.40) Dollars, being the monthly interest on balance due.)
