until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of *Legal fees least*.

All that certain piece, parcel or lot of land lying, situate and being in Greenville Township near the City of Greenville, State and County aforesaid located on the South side of West Mills Avenue and being a part of lots 5 and 7, Block 9 of the subdivision of the Estate of O. F. Miller, deceased, as shown in the Plat recorded in the R. M. C. Office for Greenville County in Plat Book 6 at page 176, and having the following metes and bounds to wit:

Beginning on South side of West Mills Avenue corner of lot formerly owned by J. G. Simpson at a point 51 feet West of the corner of lot #3 and running thence with said Simpson line N. 44-33 E. 180 feet to an alley, thence with said alley S. 45-27 W. 51 feet to a stake; thence N. 44-33 W. 180 feet to Mills Avenue thence with Mills' Avenue N. 45-27 E. 51 feet to the point of beginning, and being the same lot of land conveyed to me, the said H.
