WHEREAS, I, the said D. J. Blocker

in and by certain promissory note in writing, of even date with these presents, well and truly indebted to

Dollars, to be paid One (1) year after date

with interest thereon from date at the rate of 6 per cent. per annum, to be computed and paid semi-annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagee promises to pay all costs and expenses, including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

A certain piece parcel or lot of land in Greenville Township, Greenville County State of South Carolina, in the City of Greenville known as lot no. 31 on plat of subdivision of Mrs. I. E. Harris Estate recorded in office of R. M. C. Greenville County in Plat Book "C" page 261. Beginning at a stake on the southwest corner of Harris and Nona streets and running thence in a westerly direction with Harris street 60 feet to stake corner of lot no. 30 thence with line of lot no. 30 in a southerly direction 114 feet to stake on an eleven foot alley thence with said alley in an easterly direction 60 feet to stake on Nona Street thence with Nona street in a northerly direction 114 feet to the beginning corner being the same lot of land conveyed to me by J.
