and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage and in case said note after maturity should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings that may be had in either of said cases the mortgagor promises to pay all costs and expenses, including 10% per cent. of the indebtedness as attorney's fees, to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

all my right, title and interest, the same being an undivided one-half (1/2), in and to the following described lot, to-wit: All that certain lot or parcel of land in the City of Greenville, State and County aforesaid, lying on the West side of South Main Street, and having the following metes and bounds, to-wit:- Beginning at an iron pin on the West side of South Main Street and at the corner of an alley, and running thence with said alley N. 69.30 W. 110 feet to a cross alley; thence with said cross alley S. 20.30 W. 45.42 feet to an iron pin corner of lot no. 3 on plat hereinafter referred to thence with line of Lot no. 3 S. 69.30 E. 110 feet to an iron pin on Main Street; thence with Main Street N. 20.30 E. 45.42 feet to the beginning corner known as Lots nos. 1 and 2 on a plat of 'Markley Realty' Company, made by J.
