WHEREAS,

SEND GREETING:

in and by certain <sup>MY</sup> Promissory note in writing, of even date with these presents, <sup>and</sup> well and truly indebted to.

in the full and just sum of Three Hundred (\$300.00)

Dollars, to be paid one (1) year after date.

with interest thereon from <sup>Date</sup> at the rate of <sup>per cent.</sup> per annum, to be computed and paid *quarterly* <sup>monthly</sup>

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by <sup>date</sup> become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note <sup>after maturity</sup> should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary <sup>for the protection of his interests to date</sup>, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings, then <sup>in either</sup> <sup>SEE JUDGEMENT</sup> <sup>in cases</sup> the mortgagor promises to pay all costs and expenses, including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW, KNOW ALL MEN, That the said *J. D. Johnston* in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said

*Homes Builders Company* according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to <sup>me</sup>, the said.

*J. D. Johnston* in hand well and truly paid by the said *Homes Builders Company*

and before the signing of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain sell and release unto the said *Homes Builders Company*

All that certain lot or parcels of land situate lying and being in County and State aforesaid being on the west side of McAdoo Avenue, and being known and designated as lot no. 84 of Glenwood Park and having according to plat made by Dalton & Neess, Engineers, October 1925 the following lines and bounds, to-wit:

Beginning at an iron pin on the west side of McAdoo Avenue 171.2 feet south of the Farmers Roads, corner of lot no. 85, and running thence with lines of said lot N. 70-56 W. 150.2 feet to an iron pipe in line of lot no. 96, thence with line of that lot S. 15-48 W. 58.5 feet to an iron pipe in line of lot no. 93, thence with line of that lot S. 74-12 E. 150 feet to an iron pipe on McAdoo Avenue, thence with said Avenue N. 15-48 E. 50 feet to the points of beginning.

It is understood and agreed that this mortgage shall rank junior to a mortgage for \$300.00 and another mortgage for \$1000.00 now over said property.
