WHEREAS, I, the said *E. C. Cass*,in and by certain promises made even date with these presents, do promise and agree to pay to *And J. Barnesdale*, well and truly indebted to,in the full and just sum of *Two Thousand Five Hundred (\$2,500.00)*Dollars, to be paid *One (1) year after Date*.with interest thereon from *Date* at the rate of *8* per cent. per annum, to be computed and paid *Receiv. Annually*.

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

all that certain lot or parcel of land situate in Greenville County, Greenville City, South Carolina, near the City of Greenville, on the south side of Augusta Place Street and having known and designated as lot No. 14 as shown on a plat recorded in the Office of Register of Greenville County in plat book "A" at page 262, and having such metes and bounds courses and distances as are shown on said plat, reference to which is hereby made.

For value received, I hereby release the within described lot from the list of the mortgages of E. C. Cass to me for \$4850.00 dated November 1, 1924 recorded in Office of R. M. C. for Greenville County, S. C. in mortgage book 130 page 814.
