Barksdale*~~*all that certain lot of land near the City of Greenville in the County and State aforesaid, on the south side of the Laurens Road, in the subdivision known as "Fair Height",**Beginning at a point on the south side of the Laurens Road, 10 feet from the intersection of Laurens Road and Pickley Street and running thence with the south side of Dakota Road. N. 30. 53 W. 69 feet to point on road; thence S. 54-55 W. 176. 6 feet to corner; thence S. 33. 0 E. 50 feet to corner; thence N. 54. 32 E. 176. 3 feet to the beginning corner being designated as Lot 128. 3 in Block D on Plat of said subdivision which is recorded in the Office of the R. M.
