Office for Greenville County Dollars, to be paid in Vol. 112, page 339 et seq., in the full and just sum of Forty-five Thousand (\$45,000.00) Dollars, to be paid May 1st, 1929.

with interest thereon from date 1st 7/9 at the rate of 4 per cent. per annum, to be computed and paid annually.

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that certain lot or parcel of land situated at the Northwest corner of Washington Road and Williams Street, in Ward 11 of the City of Greenville, in the County and State aforesaid and having the following metes and bounds, according to amended plat recorded in Plat Book A page 90, R. M. & O. Office for said County, to-wit:

Beginning at the Northwest corner of Washington Road and Williams Street and running thence with Williams Street N. 15-25 W. four hundred seventy-eight and 43/100 (478.43) feet to an iron pin; thence S. 74-35 W. one hundred thirty-six and 2/10 (139.2) feet along line of other property of the mortgagor to an iron pin in line of Mrs. Mayes' lot, thence S. 15-25 E. four hundred ninety-two and 7/10 (492.7) feet along line of Mrs. Mayes' lot, thence S. 74-35 W. one hundred thirty-nine and 5/10 (139.5) feet to the Northwest corner of Washington Road and Williams Street, the point of beginning. Also all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, on the south side of Pettigree Street at the corner of Williams Street and bounded as follows:

Beginning at the Southwest corner of Pettigree and Williams Street and running thence with Williams Street 131.4 feet to Mrs. Brawley's line; thence with her line S. 74-35 W. 139.2 feet to Fair line and thence with line of Fair and Mayes in a Northwesterly direction 106.8 feet to Pettigree Street and thence with Pettigree Street in an easterly direction 140.6 feet to the beginning corner.
