Office for Greenville County; Beginning at the south east corner of Lot "E" on Earle Street and running thence N. 5 1/2 E. 200 feet to a corner; thence in parallel lines with Earle Street N. 84 1/2 W. 54 1/3 feet to corner of lot "C"; thence with line of lot "C" S. 5 1/2 W. 200 feet to Earle Street; thence with Earle Street S. 84 1/2 E. 54 1/3 feet to the beginning corner, and being all of lot "D" and the rear portion of Lot "B" of Map No. 16 as shown on plat herein before referred to, being the same lot conveyed to me by Edward J.
