Whereas, I the said

in and by my certain promise in writing, of even date with
these presents, am well and truly indebted to C. S. Marie

in the full and just sum of \$150.00, plus interest at 6% per annum (\$150.00) Dollars
to be paid three years after date,

with interest thereon from and until paid at 6% per annum

at the rate of 6 percent per annum, to be computed and paid annually
until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past
due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose
this mortgage; said note further providing for an attorney's fee of 10% of the amount due
besides all cost and expenses of collection, to be added to the amount due on the said note and to be collectible as a part thereof; if the same be placed in the
hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured
under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.

is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto the said

All that certain piece of land lying and be-
ing situated in Ward One, in the City of Greenville, on the
North side of West Stone Avenue, and being more specifically
described as follows:

Beginning at an iron pin on the North side of West
Stone Avenue, 87 1/2 ft. from the Northeast corner of West Stone
Avenue and Fourteenth Street, and running thence with West Stone
Avenue S. 84 1/2 E. 62 1/2 ft. to Stone; thence N. 84 1/2 E. 200 ft.
to a stake; thence N. 74 1/2 W. 62 1/2 ft. to a stake; thence S 85 1/2
W. 200 ft. to the beginning corner.

Said being the said lot conveyed to Elsie W. Holcombe by
H. E. Holcombe, by his deed, dated June 14, 1929, and recorded in
