SEND GREETING:

Whereas, I the said Mrs Mattie G. Mahaffey, of Greenville, County, South Carolina, on the 16th day of February, 1931, for and truly indebted to Mrs Nannie C. Robinson, of Greenville, South Carolina, in the sum of One Thousand Five Hundred Dollars (\$1,500.00) Dollars, in the full and just sum of One Thousand Five Hundred Dollars (\$1,500.00), to be paid three years after date at my convenience, of anticipating payment of any part of principal or any interest thereon, with interest thereon from the date of this note, at the rate of Seven percent per annum, to be computed and paid until paid in full, interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereon, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of \$50.00, besides all cost and expenses of collection to be added to the amount due on the said note and to be collectible as a part thereof; if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); and in and by the said note, reference being thereto had will more fully appear.

all that piece, parcel or lot of land lying in Greenville County, State of South Carolina, Greenville Township, situated in Ward One of the City of Greenville, beginning at an iron pin on the North side of Atwood Street, corner of lot owned by B.O. Woodward, and running thence with Atwood Street N. 48-0 E. 70 feet to an iron post, thence N. 42-0 W. 180 feet to a pin; thence S. 48-0 W. 70 feet to an iron pin; thence with line of B.O. Woodward S. 42-0 E. 180 feet to the point of beginning, being all of lot No. 27, plat recorded in Plat Book "E", page 132, Office of R.M.C. for Greenville County and being the same lot of land conveyed to me by Martha S. Elmore by deed dated April 21, 1931.
