in and by myself certain promissory

these presents, am well and truly indebted to Sudie Rebecca Willis Huff in the full and just sum of Four Hundred Eighty and no/100 (\$480.00) Dollars to be paid at the rate of One Hundred and no/100 (.10%) Dollars per annum with accrued interest, first payment due January 1, 1935; second payment January 1, 1936; third payment January 1, 1937; fourth payment January 1, 1938; and a fifth payment of Eighty and no/100 (\$80.00) Dollars with accrued interest January 1, 1939. The maker reserving the right to pay the whole off at any time before maturity with interest thereon from date.

at the rate of 7% per cent. per annum, to be computed and paid as above offset forth until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of ~~Ten Dollars~~ cent (.10%) besides all cost and expenses of collection, to be added to the amount due on the said note and to be collectible as a part thereof; if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.
