at the rate of 7 per cent. per annum to be computed and paid semi-annually until paid in full; all interest not paid when due to bear interest at the same rate as principal and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of

besides all cost and expenses of collection, to be added to the amount due on the said note and to be collectible as a part thereof; if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage), as in and by the said note, reference being thereto had, will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto the said

Bessie Norris Silmar, all that at piece, parcel or lot of land in Greenville Townships, Greenville County, State of South Carolina, lying, situated and being in the City of Greenville, on Arlington Avenue, and having the following metes and bounds, according to survey made by L. W. Turner Jr. Engineer.

Beginning on said Arlington Avenue at the corner of lot owned by Sam Siby, and running thence with Siby's line, S. 18 W. 150 feet to pick in other land of Sam Siby, thence with Siby's line S. 72 E. 51 feet to pick in line of Bissell's lot, thence with Bissell's line N. 18 E. 150 feet to Arlington Avenue, thence with said Arlington Ave N. 72 W. 51 feet to beginning corner. This being the same conveyed to me by L.
