Senna Irene Cox, her heirs and assigns forever, all my right, title and interest in and to, the following described property, to wit: All that certain piece, parcel or tract of land, lying and being in the Town of Mauldin, County and State aforesaid and having the following lines and bounds to wit:

Beginning at an iron pin at side of Greenville and Laurens Road, near J. S. Cooper's Stockee; thence $72\frac{1}{2}$ E. 11.70 to an iron pin in road to Conestee; thence along road S. 81 E. 1.28 to right of way of C. & W. C. R.R.; thence along said right off way N. $32\frac{1}{2}$ W. 8.31 to an iron pin; thence S. $80\frac{1}{4}$ W. 7.90 to iron pin J. S. Hill's corner; thence S. $70\frac{1}{2}$ W. 3.96 to iron pin on N. side of Greenville and Laurens Road, R. A.
