until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of ten per cent. of the amount due besides all cost and expenses of collection, to be added to the amount due on the said note and to be collectible as a part thereof; if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereto had, will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto the said

B. F. Rush, the following described property, to wit: All that tract or lot of land in Greenville Township, Greenville County, State of South Carolina, lying and being in Ward Two of the City of Greenville on the East side of North Main Street, having a frontage thereon of 42 $\frac{1}{2}$ feet, more or less, and running back in parallel lines 226 feet, more or less, to Brown Street, and having the same frontage of 42 $\frac{1}{2}$ feet on said Brown Street. Bounded on the South by lots now or formerly owned by S. O. Shelton and W. W. Burgess; on the East by Brown Street; on the North by lots of F. Jordan, J. N. Herren and R. N. Tannahill on the West by North Main Street. Subject, however, to the allegations heretofore established by an agreement which is off record in the R. M. C. Office for Greenville County in Deed Book, Vol. 12 at Page 529. Being the same lot of land described in Deed of Sydney Bruce to the mortgagor herein dated June 9, 1930 and recorded in the R. M. C. Office for Greenville County in Vol. 137 at Page 329. This mortgage constitutes a lien on the above described premises junior to the following mortgages:

2. Mortgage of L. O. Milford to B. F. Rush in the original sum of \$3000.00 dated April 26, 1933, recorded in the R. M. C. Office for Greenville County in Mortgage Book 240 at Page 209, upon which there is due as principal the sum of \$3,000.00. It is further understood and agreed that the mortgagor in case any taxes of any kind should be levied against this lot or mortgaged indebtedness, then in such case the mortgagor shall pay said taxes.
