sold and released, and by these presents do grant, bargain, sell and release unto the said _____
City View Water & Sewer Commission

all that tract or lot of land in Greenville Township, Greenville County, State of South Carolina.

On the west side of West Washington Street at the corner of Walnut Street and being known and designated as lot No. 12 of Block H of the Cagle and Mauldin property, as shown on a plat of the same recorded in Plat Book A, page 107, and also, in Plat Book E., page 242, reference to which plats is hereby made. Said lot has a frontage on West Washington Street Extension of 70 feet and a depth of 150 feet and having been conveyed to A. McGee by Essie V. Moore by two deeds, one dated February 11, 1935 and recorded in Volume 178, page 376, and the other being dated February 9, 1938, and to be recorded.

Also all that certain piece, parcel or lot of land situate on Center Street, in the subdivision known as City View, near the City of Greenville, County and State aforesaid, and being designated as lot No. 20 of Block E, as shown on plat of said subdivision recorded in Plat Book E., page 124, R. M. C. Office for Greenville County, the said lot having a frontage of 50 feet on Center Street and a depth of 168.6 feet on one side and 172 feet on the other side and being the same ^{lot} conveyed to A. McGee by R. E. Ballinger August 7, 1928 by deed recorded in Volume 127, page 171.

Also all that certain piece, parcel or lot of land situate on the North side of Echols Street in the city of Greenville being known and designated as lot No. 5 of the Heyward property as shown on a plat made by Dalton & Neves, engineers, in November 1938, said lot having a frontage of 68 feet, more or less, on Echols Street and a depth of 68 feet more or less along the line of property now or formerly belonging to the estate of J. J. McSwain and being the same lot conveyed to A. McGee by A. Louise Heyward, Ronald W. Middleton, and Basil N. Middleton by deed dated December 28, 1938 and to be placed on record.
