E. Dalton, May, 1939, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book M, at page 13, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the West side of North Main Street at joint front corner of Lots No. 9 and 22 of Block B and running thence with the center of a 10 foot alley which is the joint line of Lots No. 9 and 22 in a Westerly direction 188.2 feet to an iron pin at joint rear corner of Lots No. 9 and 10; thence with line of Lot No. 10 in a Northeasterly direction 197 feet to an iron pin in the South line of Block D; thence with line of Block D in an Easterly direction 99.2 feet to an iron pin on the West side of North Main Street; thence with the West side of North Main Street, S. 00-05 W. 114 feet to the beginning corner.
