"All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Gantt Township, being located on LaMont Lane, just off the Old Anderson Road, State Highway #81, about 4½ miles West of Greenville and being known and designated as Tract No. 35 as shown on plat of Dixie Farms being a subdivision of the property formerly owned by the First Carolina Joint Stock Land Bank, said plat being made by Dalton & Neves December 1939) and recorded in the R. M. C. office for Greenville County in Plat Book L, at pages 3 and 5, said tract containing .90 acresond being more particularly described as follows:
