All that certain tract of land in Paris Mountain Township, Greenville County, State of South Carolina, on the north side of Farr's Bridge Road, containing 2.06 acres, more or less, according to plat of J. C. Hill, L. S., April 3, 1948, and having the following metes and bounds according to said plat:

BEGINNING at an iron pin on the north side of the Farr's Bridge Road, at corner of property of J. W. Bagwell, and running thence with Bagwell line N. 52 E. 801 feet to a poplar on branch; thence with the meanders of the branch in a northwesterly direction 111 feet to a stone; thence S. 39 W. 117.48 feet to an iron pin; thence S. 60 W. 91.08 feet to an iron pin; thence S. 40 W. 121.44 feet to an iron pin; thence S. 24-30 W. 145.2 feet to iron pin; thence S. 16 W. 165 feet to iron pin; thence S. 24 W. 165 feet to iron pin on the north side of Farr's Bridge Road; and thence with Farr's Bridge Road S. 71 W. 125 feet to the beginning corner.
