grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, near the City of Greenville, and being known and designated as lots Nos. 9 and 10, as shown on plat of Haynsworth Heights, property of H. L. Baumgardner and L. T. Jones, said plat being recorded in Plat Book V, at Page 65, and having according to said plat the following metes and bounds, to-wit:

"BEGINNING at a point on the Western side of Unnamed Road, joint front corner of lots Nos. 8 and 9, which point is 281.5 feet in a Northeasterly direction from the new intersection of said Unnamed Road and Haynsworth Road, and running thence along joint line of lots Nos. 8 and 9, N. 44-12 W. 200 feet to point on line of lot No. 4, joint rear corner of lots Nos. 8 and 9; thence along line of lot No. 4, N. 46-28 E. 120 feet; thence S. 44-12 E. 200 feet to iron pin on Western side of Unnamed Road; thence along said Unnamed Road, S. 46-28 W. 120 feet to the beginning corner."
