WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Paris Mountain Township, on the Southwest side of Altamount Road, on Paris Mountain, and being a portion of Section B as shown on a Plat of the Paris Mountain-Caesar's Head Development Company, prepared by Pickell and Pickell, Engineers, and being more particularly described according to a more recent survey prepared by J. C. Hill September 16, 1947, as follows:

"BEGINNING at an iron pin on the Southwest side of Altamount Road at the joint front corner with lot now or formerly owned by W. T. Osteen, and running thence along said Osteen line, S. 63-45 W. 360 feet to an iron pin; thence N. 40-45 W. 364.2 feet to a stake at corner of lot now or formerly owned by Mabel Baker Derrick; thence with said Derrick line, N. 59-10 E. 219.5 feet to a nail and cap on the Southwest side of Altamount Road; thence with the Southwest side of Altamount Road the following courses and distances: S. 39-10 E. 25 feet; S. 48-30 E. 50 feet; S. 56-30 E. 100 feet; thence in a Southeasterly direction with said road 261 feet to the beginning corner."
