All those certain piece, parcels or lots of land situate, lying and being on the southern side of Palmetto Avenue in a subdivision known as "Riverside", being known and designated as Lots Numbers Four and Five (Nos. 4 and 5), in Block "E", of said subdivision and being described according to a plat of "Roverside" recorded in the R.M.C office for Greenville County, South Carolina, in Plat Book "K" at page 281; and according to said plat having the following metes and bounds, courses and distances, to-wit:

BEGINNING at a point on the southern side of Palmetto Avenue at the joint front corner of Lots Nos. 5 and 6 (which point is 314 feet from the southwestern intersection of Palmetto Avenue and Sumter Street) and running thence along the common line of said lots, S. 10-15 W. 125 feet to a point on the northern side of a 15-foot alley; thence along the northern side of said 15-foot alley, N. 79-45 W. 100 feet to a point, the joint rear corner of Lots Nos. 3 and 4; thence along the common line of said last mentioned lots, N. 10-15 E. 125 feet to a point on the southern side of Palmetto Avenue, the joint front corner of Lots Nos. 3 and 4; thence along the southern side of Palmetto Avenue, S. 79-45 E. 100 feet to the beginning corner.
