Now, Know All Men, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the North side of Gallivan Avenue in that area recently annexed to the City of Green-ville, in Greenville County, South Carolina, being shown as Lot 56 and the Western one-half (1/2) of Lot 57 adjacent thereto, as shown on Plat of North Park made by Dalton & Neves, Engineers, May 1940, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "K", at pages 48 and 49, and having, according to said plat and a recent survey made by R. W. Dalton, Surveyor, Mar. 7,1950, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of Gallivan Avenue, said pin being 162.8 feet East from the Northeast corner of the intersection of Gallivan Avenue and North Main Street, and running thence along the North side of Gallivan Avenue S 65-32 E 93.65 feet to an iron pin in the center of the front line of Lot 57; thence through the center of Lot 57 N 19-46 E 175.05 feet to a point in the center of the rear line of Lot 57; thence N 68-34 W 91.6 feet to an iron pin; thence along the rear line of Lots 53, 54 and 55 S 20-28 W 170 feet to an iron pin on the North side of Gallivan Avenue, the beginning corner.
