WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, CREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated

herein by reference in the sum of Forty-two Handred and No/100- - - Five (5%)

DOLLARS (\$ 4200.00), with interest thereon from date at the rate of per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the Western side of Assembly Street (formerly Belmont Avenue), near the City of Greenville, being shown as Lot No. 15 on Plat of Ethel Y. Perry Estate made by W. J. Riddle in September 1944, recorded in Plat Book B at Page 33, and described as follows:

"BEGINNING at a stake on the Western side of Assembly Street 162.5 feet South from Paris Mountain Avenue at corner of Lot No. 16, and running thence with the line of said lot, S. 54-28 W. 113.5 feet to a stake at corner of Lot No. 12; thence with the line of said let S. 5-35 E. 60 feet to a stake at corner of Lot No. 13; thence with the line of Lets Nos. 13 and 14, W. 64-28 E. 113 feet to a stake on Assembly Street; thence with the Western side of Assembly Street, N. 5-11 W. 60 feet to the beginning corner."
