"BEGINNING at an iron pin at the joint front corner of Lots Nos. 64 and 65, and running thence with the line of Lot No. 64, N. 67-50 E. 189.6 feet to an iron pin on a 20-foot alley; thence with the West side of said alley, N. 18-32 W. 67.95 feet to an iron pin, corner of Lot No. 66; thence with the line of Lot No. 66, S. 67-52 W. 189.2 feet to an iron pin on Mary street; thence with the East side of Mary street, S. 18-09 E. 68 feet to the point of beginning, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed
