"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the West side of Miller Street and the South side of Arlington Avenue in the City of Greer, having the following courses and distances: Beginning at an iron pin on the West side of Miller Street, corner of Mrs. T.W. Glenn's lot, and running thence with the West side of Miller Street 102 feet to Arlington Avenue; thence with the South side of Arlington Avenue in a Westerly direction 199 feet to the corner of T.N. Clement's lot; thence with Clement's line in a Southerly direction 86 feet to iron pin on line of Glenn lot; thence with the Glenn line in an Easterly direction 187 feet to the beginning corner.
