All that certain piece, parcel or lot of land in the city of Green-ville, Greenville Township, county of Greenville, state of South Carolina, being known and designated as lot No. 71 of the subdivision known as Vista Hills, as shown on plat thereof recorded in the R.M.C. Office for Greenville County in plat book "P" page 149, and having according to a survey made by R. W. Dalton, Engineer, June 1951, the following metes and bounds, courses and distances to-wit:

Beginning at an iron pin on the northwest side of Ridgecrest Prive, the front joint corner of lots 70 & 71, and running thence with the joint line of said lots N. 39-15 W. 178 feet to an iron pin in line of Stone property; thence with the line of said property S. 50-14 %. 77 feet to an iron pin corner of lot No. 72; thence with the line of said lot S. 39-15 E. 177.3 feet to an iron pin on the northwest side of Ridgecrest Drive; thence with the northwest side of said street N. 50-45 E. 77 feet to the beginning corner.

Also, one 30 gallon electric water heater, oil floor furnace, and disappearing stairway.
