in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said The People's National Bank, Greenville, South Carolina, under agreement with the Shriners Hospital for Crippled Children, Greenville, South Carolina, its successors and assigns, all that piece, parcel or lot of land with the buildings and improvements thereon, on the South side of Woodruff Road owned by E. R. Kellett, containing 1.75 acres, more or less, as shown on plat thereof prepared by Pickell & Pickell, Engineers, March 4, 1947 and being more particularly described according to said plat as follows:

BEGINNING at an iron pin in a county road at a point approximately 3/4 of a mile from the Woodruff Road and running thence with said county road S. 24-00 E. 200 feet to an iron pin in said road at joint corner of the land of E.
