TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, **Henry B. Williams, III** (hereinafter referred to as Mortgagor). SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto **Citizens Lumber Company, a Corporation** (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Twelve Hundred Fifty and No/100**

DOLLARS (\$ 1250.00 ),

with interest thereon from date at the rate of **six (6%)** per centum per annum, said principal and interest to be repaid: **in monthly installments of \$12.50 each on the 22nd day of each month hereafter until paid in full; said payments to be applied first to interest and then to principal, with interest thereon from date at the rate of 6% per annum, to be computed semi-annually and paid monthly.**

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, **in the City of Greenville, on the eastern side of Anderson Street, and having the following metes and bounds, to-wit:**

"BEGINNING at an iron pin on Anderson Street, 50 feet from the intersection of Nichols Street and Anderson Street, at the corner of other property of Eliza Johnson, and running thence with Anderson Street, S. 11 1/2 W. 50 feet to corner of lot now or formerly owned by Griffin; thence with line of Griffin lot in a Southeasterly direction, 105 feet to corner of lot now or formerly owned by T. C. Gower; thence with line of said lot, N. 11-30 E. 57 feet to corner of other property of Eliza Johnson; thence with line of said property in a Southwesterly direction 105 feet to the point of beginning."

Being the same premises conveyed to the mortgagor by deed recorded in Volume 422 at Page 385.

It is understood that this mortgage is junior in lien to a mortgage executed by the mortgagor to the mortgagee recorded in Book of Mortgages 496 at Page 105.
