Hill, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the east side of Tindal Road at a point 20 feet south of the corner of Lot No. 24, which point is also 131.5 feet south of the intersection of Woodland Drive, and running thence S. 88-53 E. 55.8 feet to an iron pin; thence S. 39-10 E. 122.5 feet to an iron pin at the rear corner of Lots 22 and 26; thence along the line of Lot No. 26, S. 88-15 W. 133.7 feet to an iron pin at the corner of said lot on the east side of Tindal Road; thence along the east side of Tindal Road, N. 0-28 E. 100 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
