"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northeastern side of Claremore Avenue in that area recently annexed to the City of Greenville, being shown as Lot No. 30, Block I, Section 5 on Plat of East Highland Estates, made by Dalton & Neves in February 1941, recorded in Plat Book K at Pages 78 through 80, and described as follows:

"BEGINNING at an iron pin on the Northeastern side of Claremore Avenue at the joint front corner of Lots Nos. 29 and 30, and running thence with the line of Lot No. 29, N. 50 E. 174 feet to an iron pin; thence along the Southwestern edge of a five-foot strip reserved for utilities, N. 31-01 W. 95 feet to an iron pin; thence along the line of Lots Nos. 31 and 33, S. 42-45 W. 194.5 feet to an iron pin on the Northeastern side of Claremore Avenue; thence along said Avenue following the curve thereof (chord being S. 43-33 E.) 70 feet to the beginning."
