Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in instalments of Twenty-Two and 50/100 - -

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, ac-

cording to the terms of said note, and also in consideration of the further sum of Three Dollars to me,

Frances Elizabeth Potts in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, atuate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being known and designated as the southern portion of Lot No. 72 of the property of G. J. Douglas Estate according to a plat thereof recorded in the R.M.C office for Greenville County in Plat Book F, at page 126 and having the following metes and bounds, to-wit:

"B GINNING at an iron pin on the northern side of Douglas Avenue at the joint front rner of Lots 71 and 72, and running thence along the joint line of said lots, in a sortheasterly direction, 125 feet to a point; thence on a new line through Lot No. 72, N. 59-00 W. 75 feet to a point on the line of Lot No. 73; thence along the line of that lot, in a southwesterly direction, 125 feet to an iron pin on the northern side of Douglas Avenue; thence along the northern side of Douglas Avenue, S. 59-00 E. 75 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being a portion of the property conveyed to me by James T. Fonville by his deed dated June 27, 1947 and recorded in the R. M. C. office for Greenville County in Vol. 314, at page 323."
