Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in instalments of

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the northeast corner of intersection of Furman Road and Starnes Street, near the City of Greenville, being shown as Lot 24 on plat of San Souci Highlands, recorded in the R.
