full and just sum of Three Thousand, Two Hundred and No/100 (\$ 3,200.00
Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in instalments of
Thirty-Two and No/100 (\$ 32.00) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being the research hand.

Finley in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Eastern side of Webster Street in the Slater Manufacturing Company Village at Slater, and known and designated as Lot 25, Block D, as shown on a plat entitled "Plat of Village, S. Slater & Sons, Slater, S. C.," made by J. E. Sirrine & Co., Engineers, Greenville, S. C., July 10, 1940, revised July 16, 1940, and recorded in the R. M. C. office for Greenville County in Plat Book M, at pages 148 and 149, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Eastern side of Webster Street at the joint front corner of Lots 25 and 26, and running thence along the Eastern side of Webster Street, N. 2-34 W. 70 feet to an iron pin at the joint front corner of Lots 24 and 25; thence along the common line of said two lots, N. 87-26 E. 125 feet to an iron pin at the joint rear corner of Lots 8 and 25; thence along the common line of said two lots, S. 2-34 E. 70 feet to an iron pin at the joint rear corner of Lots 25 and 26; thence along the common line of said two lots, S. 87-26 W. 125 feet to an iron pin, the point of beginning, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same lot of land conveyed to us by J. P. Stevens & Co., Inc. by deed dated August 15th, 1951, not yet recorded."
