NOW KNOW ALL MEN. That I, the said Richard C. Lee
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, ac-
cording to the terms of said note, and also in consideration of the further sum of Three Dollars to me,
the said Richard C. Lee
in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE . at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE , the following described property, to-wit:
"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed
thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in
Greenville Township, within the corporate limits of the City of Greenville, being known and designated as all of Lot 64 and the eastern portion of Lot No. 63 of a sub-
division known as North Park as shown on plat thereof recorded in the R. M. C.
office for Greenville County in Plat Book K, at pages 48 and 49, and having the follow
ing metes and bounds, to-wit:
"BEGINNING at an iron pin on the south side of North Park Drive (formerly

Griffin Avenue) at the corner of a lot heretofore conveyed to Bina V. Dacus, which point is approximately in the center of the right-of-way for the Greenville City Water main from Paris Mountain, and running thence along the south side of North Park Drive, S. 68-34 E. 93 feet to an iron pin at the corner of Lot No. 65; thence along the line of that lot, S. 19-43 W. 169.2 feet to an iron pin at the rear corner of said lot; thence N. 68-34 W. 93 feet to an iron pin in the rear line of Lot No. 63 at the rear corner of the lot of Bina V. Dacus; thence along the line of that lot, N. 19-43 E. 169.2 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
