TO ALL WHOM THESE PRESENTS MAY CONCERN: We, A. M. Spivey and Geneva Spivey

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, about five miles from the city of Greenville, being known and designated as lot No. 92 on map No. 3, Sans Souci Heights, property of Ben F. Perry and having according to the plat thereof, recorded in plat book Z page 95, the following metes and bounds, to-wit:

Beginning at an iron pin on the east side of Tindal Road, the joint corner of lots No. 91 & 92, and running thence with the joint line of said lots S. 74-15 E. 110 feet to corner of lot No. 98; thence with the line of said lot S. 27-55 W. 75 feet to corner of lot No. 93; thence with the line of said lot N. 74-15 W. 110 feet to an iron pin on the east side of Tindal Road; thence with the east side of said road N. 27-55 E. 75 feet to the beginning corner.
