"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, shown as the Southeastern 55 feet of Lot No. 86 on Plat of Westview, made by C. M. Furman, Jr., Surveyor, recorded in the R. M. C. Foffice for Greenville County, S. C. in Plat Book "PM". Pages 139-140, and having, according to said plat, the following meter
