in the full and just sum of Ten Thousand (\$10,000.00) Dollars, in and by my certain promissory note in writing of even date herewith, due and payable one year from date, with the right to prepay any amount thereon before maturity without penalty,

with interest from date at the rate of Five (5%) per centum per annum until paid; interest to be computed and paid monthly and if unpaid when due to bear interest at same rate as principal until paid, and I have further promised and agreed to pay ten per cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceedings of any kind, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I the said Analano C. Gibson,

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

R. K. Campbell, Trustee, his successors and assigns, all that piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina about 21 miles from the Greenville County Court House and on the northwesterly side of the Old Spartanburg Road and described by notes and bounds and courses and distances as follows:

BEGINNING at a point at the intersection of East North Street Ext. and White Oak Drive and running thence along the northern line of E. North Street Ext. S. 55-00 W. 470 feet to point at the Southeast corner of property of Lora Campbell; thence running along the eastern boundary of Lora Campbell's lot N. 25-00 W. 102.5 feet; thence along the northern boundary of the Lora Campbell lot S. 55-00 W. 95 feet; thence N. 22-40 W. 122.2 feet to a point in line of Central Street; thence running along the southern line of said Street N. 54-25 E. 500 feet to a point in the western line of White Oak Drive; thence along the western line of White Oak Drive S. 43-37 E. 292 feet to the beginning point.
