To All Whom These Presents May Concern: Wm. Bennett,  
T. J. Pearson, and J.H. Wilson, Trustees of the Assembly of God Church of  
Greer, S.C., send greeting.

Whereas, we, the said Trustees, Wm. Bennett, T.J. Pearson,  
Trustees of the Assembly of God Church of Greer, S.C.,  
in and by the certain promissory note in writing, of even date with these  
Presents, are well and truly indebted to E.P. Edwards,

in the full and just sum of One thousand and no/100 dollars (1000.00)

to be paid one-third of entire amount, with interest  
every year for three years, entitling him to be paid three years from  
date of Note and Mortgage.

with interest thereon, from date  
at the rate of seven per centum per annum, to be computed and paid annually

until paid in full; all interest not paid when due to bear  
interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,  
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the  
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof  
necessary for the protection of his interests to place and the holder should place the said note or this mortgage  
in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises  
to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to  
the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

sum of money aforesaid, and for the better securing the payment thereof to the said E.P. Edwards  
according to the terms of the said note, and also in  
consideration of the further sum of Three Dollars, to us, the said mortgagors

in hand well and truly paid by the said E.P. Edwards  
at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained,  
sold and released, and by these Presents do grant, bargain, sell and release unto the said E.P. Edwards  
and his heirs and assigns:—X

THAT certain lot of land, with improvements thereon, in Chick Springs  
Township, Greer School District, said County and State, South of the  
town of Greer, and designated as Lot # 1 in Block C on plat of the  
D.D. Davenport estate, prepared by H. C. Brockman, Surveyor, October 17th  
1940, said Lot lying between the Woodruff Surrounded Road or State Highway  
# 101, and Lime Street Extension, and on which is situate the Church  
building of the said local Church, and described as follows:

BEGINNING at point South of Snow Street and east of Lime Street Extension  
where said roads cross; and runs thence with Lime Street Extension,  
S 6-45 W 316-2 feet to the corner of Lot No. 2 on said extension.
