To All Whom These Presents May Concern:

I, Jack Moore

SEND GREETING

Whereas, I the said Jack Moore

in and by certain promissory note in writing, of even date with these Presents, am well and truly indebted to The Palzer-Williamston Bank

in the full and just sum of Four thousand ----- (\$4,000.00)-----
-----Dollars to be paid on demand after date

with interest thereon from date at the rate of 6 per centum per annum, to be computed and paid semi-annually

until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, of the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or the mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness at attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW KNOW ALL MEN, That I the said Jack Moore

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said The Palzer-Williamston Bank according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me the said Jack Moore

in hand well and truly paid by the said The Palzer-Williamston Bank at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said The Palzer-Williamston Bank, its successors and assigns forever:

All that piece, parcel or lot of land with improvements thereon in Dublin Township, Greenville County, State of South Carolina, containing 1.6 acres, more or less, bounded on the North by Beal Springs Road, East by Cooley Bridge Road, South and West by lands of Mitchell C. Moore, and all that being the line of said tract, said tract of land being more particularly described on a plat prepared by Dalton & Haven, Surveyors, dated July, 1946 as follows:

beginning at a point on Cooley Bridge Road, the Northeast corner of this tract, and running thence N. 55-30 W. 100 feet to a point; thence N. 52-15 W. 43 feet to Beal Springs Road; thence along Beal Springs Road S. 23-45 W. 100.5 feet to an old road; thence along the old road S. 6-37 E. 77.3 feet to a point; thence S. 23-49 W. 20.6 feet to Cooley Bridge Road; thence along Cooley Bridge Road N. 4-56 W. 210.0 feet to the point of beginning.
