WHEREAS, we the said Waymon W. and Lila Bell Staton
in and by our certain promissory note in writing of even date with these Presents, are well

Eighteen hundred and no/100 - - - - (\$ 1800.00) Dollars, with interest from the date hereof at the rate of **seven** per cent (**7**%) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of

C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to us the said mortgagor. In hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Citizens Building and Loan Association, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, High-land Township, lying on both sides of the Saluda Gap Road, and being shown on plat of property of W. W. Staton prepared by W. P. Morrow, Surveyor, March 29, 1947, and having the following courses and distances, to-wit:-

Beginning at an iron pin in said Road, joint corner of tract sold to D. H. Bates, and running with the Bates line S 44-15 W 435 feet; thence N 86-00 W 580 feet to a stone, corner of W. H. Pitman land; thence with the Pitman line S 4-00 E 1024 feet to a stone; thence N 35-10 E 970 feet to a stone; thence S 79-00 E 775 feet to iron pin in a road; thence with road N 31-00 E 175 feet to stake in road; thence S 66-45 E 285 feet; thence N 30-00 E 150 feet to center of Saluda Gap Road; thence therewith N 66-30 W to stake, corner of tract sold to Fred E. Howard; thence with the Howard line N 37-45 E 785 feet to point on line of Turpin line; thence with the Turpin line N 63-45 W 497 feet to a stone
